APPLICATION INFORMATION FOR STUDENTS

Who can apply to FFS Lund (Friluftsrämjandet Student Lund)

Any active student above 18 year.

Compulsory membership in Friluftsrämjandet

Friluftsrämjandet is a membership-organization and to participate in our activities both participant and leaders must be members.

In order for Friluftsrämjandet's accident insurance* to be valid the membership fee shall be paid **before** you take part in your first activity with us.

*The insurance is valid for EU and Schengen citizens only. **If you are from a country outside of this area, we strongly advise you to arrange for private medical/accident insurance. Friluftsrämjandet is not responsible for any such costs you may incur in relation to participating in our activities.**

The membership is valid from 1st October 2016 to 30th September 2017.

If you sign up from 1st June you are automatically a member to 30 Sep. 2017.

The year which you are born is deciding of the fee.

Youth 13 – 25 years	SEK 170
Adult 26 and above	SEK 360

Participation fee

Apart from the compulsory membership fee, Lund's local branch charges a participant fee for the activity that you take part in. In this case all activities organized by our FFS Lund. This fee is to be paid every term.

How do I pay?

For all students an invoice for the current FFS Lund participation fee of SEK 100 will be sent to you via email from our office in the beginning of every term, later if you join mid-term. Normally you have 15 days to pay the invoice.

If you are **new** to Friluftsrämjandet, the membership fee will be added to this invoice.

If you **already are a member**, you are responsible for making sure that you renew your membership by paying the invoice from our Stockholm HQ. You will receive it together with the 3rd issue of the magazine *Friluftsliv* in September yearly.

Contact details

It is important that email-addresses and cell phone numbers which you state in the application form are accurate as the leaders and the office use them to communicate and send invoices. Don't forget to contact our office when your details need to be updated.

Personal identity number or Social security number

For all students registered in Sweden we need your complete *personnummer*. For foreign students who do not have the last 4 digits we need your date of birth (year-month-day). This data will be used in case the leaders or the office need to contact a hospital or SOS Alarm, and also when we apply for funds from i.e. the City of Lund.

Meeting point

The place from where the activity starts, and it will be decided by the leaders. If the group travels by bus, an extra surcharge can be added.

PuL

By applying you accept that we use your persona data according to PuL (personuppgiftslagen = Personal information law).
